She has been employed with the County of San Bernardino since 1990 and currently serves as the Division Chief of Community Health Services and Chief Executive Officer for the four Federally Qualified Health Care Centers in San Bernardino County. During her tenure with the Department of Public Health, Jennifer has served as a Deputy Chief, Community Health Services; Public Health Program Manager and Public Health Program Coordinator. She has also served in various capacities which include Maternal Child & Adolescent Health Co-Director, Adolescent Family Life Program Director and Child Health Disability Prevention Program Deputy Director for the County of San Bernardino.

As a Public Health Program Manager, Jennifer has actively worked with public and private partners to assure that the unique health needs of the community are addressed through a data driven efforts for health promotion, prevention and access to care. Throughout her career, she has had the opportunity to establish strong networks of social and health care contacts in the arena of prevention, treatment services and resource acquisition (local, state and federal, private and public, health, medical, psychosocial and environmental, education and research) to assist in improving the needs of children and families at risk.
